1. The EMUI_ EuroMed University (EMUI)

International Academic and Research Center (Union for the Mediterranean), Tax Number: ESG87905626, the EMUI_ EuroMed University, www.emui.eu, is a Interuniversity Platform for Innovation (Research, Higher Teacher and Training - LLP), by adapting existing (or new design) projects and programs to the Priorities of the Horizon EU Framework Program 2020. Joint management and open offer, especially for students from Southern Mediterranean countries.

As a public institution the EMUI is a member of the Anna Lindh Foundation - EUROMED, networks Malta, Spain and Italy, respectively from 2008, 2014 and 2017, www.emui.eu/annalindh_foundation.html

Through the Union for the Mediterranean (UfM) the EMUI will collaborate in designs of actions and priority programs that involve innovation at the level of styles and teaching techniques based on the specific demands of specific training. EMUI programming is intended to be complementary to other existing similar ones, without duplicity with respect, especially, to the offer made by the Euro-Mediterranean University EMUNI (Piran Slovenia) and the Euro-Mediterranean University of Fes UEMF (Morocco)

2. The Mediterranean Citizens' Assembly Foundation (FACM)

It is a citizen's network of dialog, proposal and action founded in the democratic values of freedom, peace, respect for cultural diversity and environmental responsibility (www.fundacionacm.org/en/) CIF: G98786601

It aims to favour the emergence of a common voice and a common citizens' action in the area of the Mediterranean through the action and involvement of citizens, both men and women, that a united an positive "community of destiny" will be set up in the Mediterranean. The Citizen's nature involved in all the activities is a key component in itself.

As a public institution the FACM is a REFAL member (Red Española de la Anna Lindh Foundation)

The goal is to contribute to the construction of a sustainable area of peace, development, solidarity and shared prosperity: enhance economic and political integration in the regional framework boosting the emergence of the dialog and the common citizen action.

We participate in the organization of meetings, seminars, workshops, projects and iniciatives of actions in the Mediterranean, with special attention to youth and women; edition of publications, common strategies and specific proposals.

3. The EMUI_ EuroMed University and the Mediterranean Citizens' Assembly Foundation (FACM)

have agreed to cooperate in the projects that follow the priorities of the Union for the Mediterranean, especially on the following fields:

- a) Developing and implementing joint projects in the fields of joint concern.
- b) Organising conferences, trainings and other joint events
- Supporting students and staff exchange, including through internship programmes of EMUI students at FACM
- d) Additional activities agreed by both EMUI University and FACM

EMUI EuroMed University and FACM will define each joint activity with special agreement where all the activities, obligations and other issues will be specified.



4. Participation of Mediterranean Citizens' Assembly Foundation (FACM) in the EMUI Social Council

In accordance with the EMUI Statutes and Regulations (OBEMUI, Official Bolletin of the EMUI, Nr 20/2017.1):

«§ Artice 3.- SOCIAL COUNCIL (SC)

»The Social Council is the guarantor of the economic-financial and socio-political stability of the institution. It represents the complexity of civil society: States of opinion and public policies at different levels (local, regional, national and international)

»3.1 Composición.- With foundational shall consist of: President, Spanish Companies, Italian Companies, EU, Maghreb & Middle East Companies, Mayor of Lecce, President of the Puglia Region, International Foundation for Human Rights (representing civil society), Representative of the Direction Council and the Management Office (Manager), which assumes the **Secretary of the SC**.

»3.2 Functions.-

- Ensuring academic and financial support necessary for the normal development of activities for approval propose the Direction Council (DC);
- b) Manage the funds received, both public and private institutions;
- c) Attracting additional resources, preferably under the relevant calls; and
- d) Intervene expenses and use of budgetary allocations .

»3.3 Guarantee system.-

- a) The Direction Council (DC) can not approve research research projects, academic, cultural, or formation programs of ordinary character, proposed by Academic and Research Council (AC), without a **prior report** of the Social Council (SC);
- b) The SC, in its capacity for guarantor of economic stability of the project, and in Relation to Section 1.2 and 1.2.1 (Statutes and Reulations), after hearing the authorities involved, issue reports in parallel with binding character, on the likely socioeconomic impact and financial viability of projects and programs.
- **»3.4** The SC will manage the addition thereto of political representatives of the countries concerned at the level of representation that has already Italy (Puglia Region and the Municipality of Lecce). SC function is also ensuring **cooperation at the regional level** on specific projects»

5. Based on the above, the institutions that sign this document agree on the following:

- 1. The FACM is incorpored to the EMUI Social Council as a full member status.
- 2. This involvement exclude any economical committement from the FACM side and in any case .
- The FACM, as a member of the Social Council will ensure the transversality of the programs of the EMUI, especially as far as the mutual impact of cultures is concerned.
