#### 1. PREAMBLE

## 1.1 The EMUI\_ EuroMed University (EMUI)

International Academic and Research Center (Union for the Mediterranean), Tax Number: ESG87905626, the EMUI\_ EuroMed University, www.emui.eu, is a Interuniversity Platform for Innovation (Research, Higher Teacher and Training - LLP), by adapting existing (or new design) projects and programs to the Priorities of the Horizon EU Framework Program 2020. Joint management and open offer, especially for students from Southern Mediterranean countries.

As a public institution the EMUI is a member of the Anna Lindh Foundation - EUROMED, networks Malta, Spain and Italy, respectively from 2008, 2014 and 2017, www.emui.eu/annalindh\_foundation.html

Through the Union for the Mediterranean (UfM) the EMUI will collaborate in designs of actions and priority programs that involve innovation at the level of styles and teaching techniques based on the specific demands of specific training. EMUI programming is intended to be complementary to other existing similar ones, without duplicity with respect, especially, to the offer made by the Euro-Mediterranean University EMUNI (Piran Slovenia) and the Euro-Mediterranean University of Fes UEMF (Morocco)

### EMUI\_ Foundational Goals |

- 1.- To develop teaching and research quality programs focused on the European Union and its projection upon the Mediterranean Area.
- 2.- To form professionals in every area of punctual interest for European and Euro-Mediterranean institutions. These professionals will meet the standards of quality set by social, political and economic sectors involved.
- 3.- To offer programs of continuous education for updating knowledge and basic skills of the above referred professionals.
- 4.- To foster the spreading of results through specialized media. There will be also a presence in general media, according to the interests of their users.
- 5.- To draw up proposals of continuous education through courses, seminars or conferences that will be available to any citizen, with the purpose of guaranteeing accurate and critical information on the ongoing development of the EU, particularly in relation to Mediterranean issues.
- 6.- To advise public and private institutions on the aforementioned issues. Consultant panels will be set up to pursue this goal.
- 7.- To set up institutional teaching and research networks, with or without extra-communitarian partners, in order to improve the spreading of results. It will be also be a target to establish partnerships with other institutions in order to create local, regional or communitarian programs to be developed at the affected geopolitical areas.

## 1.2 The University of Sousse (Tunisia)

### 2. GOALS

- 2.1 The object of the present agreement is the design and joint offer of a University Master with the title of *Human Rights in the Mediterranean (Les Droits de l'Homme en Méditerranée)*, www.emui.eu/humanrights/master.html. International Master & PhD d'Université · 60 ECTS | e-Learning (100% / 60% / 30%)
- 2.2 The universities of the Academic and Research Council, which are listed in the following section (§ Artice 1.-), www.emui.eu/bodies/academic.html, are part of the joint offer.
- 2.3 Any other institution that forms part of the EMUI\_Universities Consortium, www.emui.eu/network\_consortium.html, can join the offer.
- 3. EMUI\_ Statutes and Regulations, provides for the following collaboration structure | Official Bulletin of the EMUI Nr 20/2017.1 (January-June)

#### **«§ Artice 1.- ACADEMIC COUNCIL (AC)**

With foundational character are represented, under agreements, the following centers: 1. Morocco: Mohammed V University of Rabat; 2. Egypt: University of Cairo; 3. Israel: Hebrew University of Jerusalem; 4. Italy: University of Salento, University of Foggia; and 5. Spain: Complutense University of Madrid. The Secretary General assumes the Secretary of AC. The Presidency of the AC corresponds to the Academic Coordinator.

**1.1.-** The AC may propose the addition thereto of other universities in the geographical, political and cultural space of the Mediterranean, it proposed to be adopted, if necessary, by the **Direction Council**, prior **nonbinding Social Council report**.

- **1.2.2.-** With the seal of EMUI\_ EuroMed University or, where appropriate, together with other universities represented in the AC, it can propose Postgraduate Own Degree (Expert, Specialist, Master and Doctorate).
- 1.2.3.- Also, with the seal of EMUI\_ Euromed University or , where appropriate , in conjunction with other universities represented in the AC, it can propose Own Degrees Continuing Education LLP (Certificate and Diploma)
- 1.3.- Type of courses (modality).- In order to encourage mobility and inter-university exchange, regardless of which institution makes the offer, it is be of three types: classroom courses, online blending learning and online course. The head teacher is contributed by the universities that have signed the corresponding qualifications, whom they will keep their status and relevant remuneration, assuming the travel costs. The EMUI\_ EuroMed University bear the costs of accommodation and meals as appropriate»

With its own legal personality, due to the legal coverage assisting the developing institutions and universities of the AC, respecting the current regulations in each of the participating States in the field of Higher Education and Research, and Community implementing legislation, the EMUI and the UNIFG are provided with the following:

#### 4. ASSUMPTIONS

- 4.1 The curriculum (Academic Syllabus) of the University Master mentioned will be agreed with each of the institutions of the CA that is accepted as its own. The joint offer can be added to the Universities of the EMUI Network.
- 4.2 Once the demand of students and institutions is probed, the offer can have the following structure: Option a) Mixed (face-to-face and virtual): a.1) one-third of the face-to-face teaching at the University of origin; one third in any other University of AC; one third online; a.2) One-third of the face-to-face teaching in any of the Universities of the AC; two thirds, virtual. Option b) Virtual 100%
- 4.3 In this sense the University of Sousse accepts to recognize as its own offer said Plan of Studies. Alternatively, for the final ECTS contribution, the University of Foggia can offer courses from their own Masters, considered complementary.
- 4.4 The academic and management responsibility of the Master will be from EMUI\_EuroMed University.
- 4.5 University of Sousse is committed to providing its faculty to teach, where appropriate, face-to-face teaching and to collaborate in the design of the virtual offer.
- 4.6 The Social Council (SC) of the EMUI guarantees, where appropriate, the mobility of students and faculty, designing a specific scholarship policy.
